Ex officio members will have full voting rights and responsibilities.

5. Term of office for each director changed from may serve consecutive terms without limit to "for a maximum of 6 consecutive years",

6. Term of office for primary officers changed from the beginning of April 1 and ending on March 31 of each year to "shall begin at the Annual Meeting when the new officers are elected," and
