**Session II: Engaging Clients in Reproductive Life Goals
Conversations in the Social Service Setting
(Lecture and Interactive Activity)**

Using an inclusive, best practice approach to reproductive life goal conversations, this interactive session will assist participants in learning how to engage clients in these conversations. In addition to teaching participants the practical skills involved in this approach, this session will review helpful counseling practices and tools and explore how implicit bias may impact these client conversations.

- Describe the steps of the PATH Framework for engaging clients in reproductive life goal conversations
- Assess a client's sexual and reproductive health needs appropriately based on their reproductive life goals
- Identify practices and tools that assist in the counseling aspects of reproductive life goal conversations and in navigating difficult client encounters or situations
- Evaluate how implicit bias and discomfort may show up during interactions with clients, especially those related to sexual and reproductive health

Session III: Strategies for Clients Experiencing Trauma, Reproductive Coercion and Contraceptive Sabotage (Lecture and Interactive Activity)

Discussing sexual and reproductive health needs with clients can reveal other client experiences that may affect their ability to engage in services confidently or safely. This session will explore how trauma, reproductive coercion and contraceptive sabotage impact a client's reproductive life goals. This session will also provide participants with strategies for how to navigate these sensitive areas and serve clients in a trauma-informed way.

By the end of this training session, participants will be able to:

- Define trauma, reproductive coercion and contraceptive sabotage and the impact of these on your client's reproductive health
- List two examples of how an intimate partner can interfere with a client's ability to use contraceptives successfully
- Summarize the CUES methodology for working with clients who have experienced trauma, reproductive coercion or contraceptive sabotage

**Session IV: Engaging Clients in Contraceptive Counseling
(Lecture and Interactive Activity)**

Building on the Engaging Clients in Reproductive Life Goals Conversations in the Social Service Setting session, this session will provide information on contraceptive methods and best practices for educating client on their contraceptive options. This session will also engage participants in practicing, through roleplays, the PATH framework skills to have Reproductive Life Goals conversations with their clients.

By the end of this training session, participants will be able to:

- Identify the FDA approved contraceptive methods
- Describe characteristics of contraceptive methods to clients to assist in contraceptive decision making.
- Integrate a patient-centered, shared decision-making approach into contraceptive counseling with clients
- Discuss reproductive health with clients, including basic pre-pregnancy health topics
- Practice, through roleplay exercises, the steps of the PATH Framework
